ADDITIONAL PROVISIONS
(DOD CONTRACTS)

The Department of Defense Supplement to the Federal Acquisition Regulation (DFARS) clause(s), as in effect on the date of this order unless otherwise specified below, which have been marked with an "x" in the appropriate box below, are incorporated herein by reference. In such clauses, unless otherwise specifically stated, the term "Contractor" means Seller except in the term "prime contractor", "subcontractor" means Seller's subcontractor, "Contract" means this order except in the term "prime contract", and "Contracting Officer" means the government contracting officer for the prime contract or authorized representative.

- A. SPECIAL PROHIBITION ON EMPLOYMENT - DFARS 252.203-7001. "Contractor", "Contract" and "Subcontractor" are not changed in paragraphs (a) and (b). In paragraph (e), "Government" means Government or Buyer. In paragraph (f) "through the Buyer" is inserted after "Contracting Officer". Paragraph (g) is deleted.
- B. OVERSEAS DISTRIBUTION OF DEFENSE SUBCONTRACTS - DFARS 252.204-7005 (August 1988). Paragraph (d) is deleted and the following inserted:

"(d) For purposes of furnishing information requested herein, the prime contract number shall be the Government contract number shown on the faceplate of this order."
- C. REQUIRED SOURCES FOR MINIATURE AND INSTRUMENT BALL BEARINGS - DFARS 252.208-7000 (July 1971).
- D. REQUIRED SOURCES FOR PRECISION COMPONENTS FOR MECHANICAL TIME DEVICES - DFARS 252.208-7001 (August 1971).
- E. REQUIRED SOURCES FOR HIGH-PURITY SILICON - DFARS 252.208-7002 (June 1983).

- G. REQUIRED SOURCES FOR ANTIFRICTION BEARINGS - DFARS 252.208-7006 (April 1989). "Offeror" means Seller, "Government" means Buyer in subparagraph (b)(2), and Contracting Officer means Buyer in paragraph (c).
- H. ACQUISITIONS FROM SUBCONTRACTORS SUBJECT TO ON-SITE INSPECTION UNDER THE INTERMEDIATE-RANGE NUCLEAR FORCES (INF) TREATY - DFARS 252.209-7000 (Previously DFARS 252.209-7001).
- I. PRICING ADJUSTMENT - DFARS 252.215-7000.

- J. IMIP PRODUCTIVITY SAVINGS REWARDS - DFARS 252.215-7001 (July 1987). "Contractor" is not changed to Seller in the fourth sentence of paragraph (b) and "contract" is not changed to this order the first and third times it appears in the third sentence of paragraph (b). The term "Government" in paragraph (b)(2) is changed to Rockwell International.
- K. SMALL BUSINESS AND SMALL DISADVANTAGED BUSINESS SUBCONTRACTING PLAN (DOD CONTRACTS) - DFARS 252.219-7003 (Previously DFARS 252.219-7000). "Contract" is not changed in paragraph (f).
- L. NOTICE OF RADIOACTIVE MATERIALS - DFARS 252.223-7004 (Previously DFARS 252.223-7000). "Contracting Officer" means Buyer and is inserted in the blank in paragraph (a).
- M. SAFETY PRECAUTIONS FOR AMMUNITION AND EXPLOSIVES - DFARS 252.223-7002 (Previously DFARS 252.223-7001). "Government" means Government and Buyer in paragraphs (b)(2), (d)(1), (d)(3) the first time it appears in (g)(1)(i), and in (g)(3).
- "Government" means Government or Buyer in paragraph (c)(3), (c)(4), (c)(5), (e)(1), (e)(1)(ii), (f)(1), (f)(2), and the second it appears in (g)(1)(i).
- "Contracting Officer" means Contracting Officer and Buyer in paragraphs (d)(1), (d)(3) and (g)(4).
- "Contracting Officer" means Contracting Officer or Buyer in paragraphs (c)(1), (c)(2), (c)(3), (c)(4), (c)(5), and (d)(2).
- "DoD" means DoD and Buyer in paragraphs (g)(1)(ii) and (g)(3).
- N. CHANGE IN PLACE OF PERFORMANCE - AMMUNITION AND EXPLOSIVES - DFARS 252.223-7003 (Previously DFARS 252.223-7002). "Contracting Officer" means Buyer and "Government" means Government or Buyer.
- O. SAFEGUARDING ARMS, AMMUNITION, AND EXPLOSIVES - DFARS 252.223-7003. "the Buyer," is inserted after "representatives of" in paragraph (b).
- P. BUY AMERICAN ACT AND BALANCE OF PAYMENTS PROGRAM - DFARS 252.225-7002 (Previously DFARS 252.225-7001). Buy American Act - Supplies FAR 52.225-3 in Buyer's Form 70-C-33 is deleted.
- Q. QUALIFYING COUNTRY SOURCES AS SUBCONTRACTORS - DFARS 252.225-7002.
- R. BUY AMERICAN ACT, TRADE AGREEMENTS ACT, AND THE BALANCE OF PAYMENTS PROGRAM - DFARS 252.225-7006. \$ is the amount in paragraph (b). Buy American Act - Supplies, FAR 52.225-3 is deleted from Buyer's Form 70-C-33.

- S. DUTY-FREE ENTRY - QUALIFYING COUNTRY END PRODUCTS AND SUPPLIES - DFARS 252.225-7009 (Previously DFARS 252.225-7008). The term "contract" is not modified in the terms "Defense Contract Management" and "DoD contracts".

- T. PREFERENCE FOR CERTAIN DOMESTIC COMMODITIES - DFARS 252.225-7012 (Previously DFARS 252.225-7009).
- U. PREFERENCE FOR DOMESTIC SPECIALTY METALS (MAJOR PROGRAMS) - DFARS 252.225-7014 (Previously DFARS 252.225-7011) and Alternate I.
- V. PREFERENCE FOR DOMESTIC HAND OR MEASURING TOOLS - DFARS 252.225-7015 (Previously DFARS 252.225-7013).
- W. DUTY-FREE ENTRY - ADDITIONAL PROVISIONS - DFARS 252.225-7010 (Previously DFARS 252.225-7014). "Contract" is not changed in paragraph (a)(2) and in the terms "DoD Contracts" and "contract administration".
- X. RESTRICTION ON ACQUISITION OF FOREIGN MACHINE TOOLS - DFARS 252.225-7016 (Previously DFARS 252.225-7023).
- Y. ACCIDENT REPORTING AND INVESTIGATION INVOLVING AIRCRAFT, MISSILES, AND SPACE LAUNCH VEHICLES - DFARS 252.228-7005 (Previously DFARS 252.228-7006).
- Z. SUPPLEMENTAL COST PRINCIPLES - DFARS 252.231-7000. "Contracting Officer" means Buyer.
- AA. FREQUENCY AUTHORIZATION - DFARS 252.235-7003 (Previously DFARS 252.235-7004). Delete "the schedule of" in paragraph (a).
- BB. ENGINEERING CHANGE PROPOSALS - DFARS 252.243-7000. "Contracting Officer" means Buyer.
- CC. PRICING OF CONTRACT MODIFICATIONS - DFARS 252.243-7001. (This clause replaces 52.215-7000 of Buyer's Form 70-C-33, Section D).
- DD. TRANSPORTATION OF SUPPLIES BY SEA - DFARS 252.247-7023 (Previously DFARS 252.247-7203). "Contractor" is not changed in paragraph (a)(1). In the first sentence of paragraph (c) "through the Buyer" is inserted after "Contracting Officer" and "45 days" is changed to "60 days".

In paragraph (d), "the Buyer," is inserted after "Contracting Officer".

In paragraph (f), "Government" and "Contracting Officer" mean Buyer and "for the purposes of the prompt payment clause of this contract" is deleted.

- EE. RECOVERY OF NONRECURRING COSTS ON COMMERCIAL SALES OF DEFENSE PRODUCTS AND TECHNOLOGY AND OF ROYALTY FEES FOR USE OF DOD TECHNICAL DATA - DFARS 252.270-7000 (Previously DFARS 252.271-7001). In paragraph (a)(7), "Contractor" is not changed. In paragraph (f), "Government" means Government and Buyer.
- FF. NOTIFICATION OF TRANSPORTATION OF SUPPLIES BY SEA - DFARS 252.247-7024 (Previously DFARS 252.247-7204). "Contracting Officer" means Buyer.
- GG. HAZARDOUS MATERIAL IDENTIFICATION AND MATERIAL SAFETY DATA - DFARS 252.223-7004 (July 1989). "Government" means Government or Buyer the first time it appears in paragraph (e) and in paragraph (g)(1), "Government" means Government and Buyer the second time it appears in (e) and in (g). In paragraph (g)(2) "That the Government is not" is changed to "Neither the Government or Buyer is."
