

FLYSHEET 104A
ADDITIONAL PROVISIONS (DOD CONTRACTS)

The Department of Defense Supplement to the Federal Acquisition Regulation (DFARS) clauses(s), as in effect on the date of this order, which have been marked with an "x" in the appropriate box below, are incorporated herein by reference. In such clauses, unless otherwise specifically stated, the term "Contractor" means Seller except in the term "prime contractor", "subcontractor" means Seller's subcontractor, "Contract" means this order except in the term "prime contract", and "Contracting Officer" means the government contracting officer for the prime contract or authorized representative.

- A. SPECIAL PROHIBITION ON EMPLOYMENT - DFARS 252.203-7001. "Contractor", "Contract" and "Subcontractor" are not changed in paragraphs (a) and (b). In paragraph (e), "Government" means Government or Buyer. In paragraph (f) "through the buyer" is inserted after "Contracting Officer". Paragraph (g) is deleted.
- B. ACQUISITIONS FROM SUBCONTRACTORS SUBJECT TO ON-SITE INSPECTION UNDER THE INTERMEDIATE-RANGE NUCLEAR FORCES (INF) TREATY - DFARS 252.209-7000.
- C. PRICING ADJUSTMENTS - DFARS 252.215-7000. "Subcontractor" is not changed.
- D. INDUSTRIAL MODERNIZATION INCENTIVE PROGRAM - DFARS 252.215-7003. Delete the words "directly between the Government and the Contractor" in the second sentence of section (a).
- E. SMALL BUSINESS AND SMALL DISADVANTAGED BUSINESS SUBCONTRACTING PLAN (DOD CONTRACTS) - DFARS 252.219-7003. "Contract" is not changed in paragraph (f).
- F. SAFETY PRECAUTIONS FOR AMMUNITION AND EXPLOSIVES - DFARS 252.223-7002. "Government" means Government and Buyer in paragraphs (b)(2), (e), the first time it appears in (g)(1)(i), and in (g)(3).

"Government" means Government or Buyer in paragraph (c)(3), (c)(4), (c)(5), (e)(1), (e)(1)(ii), (f)(1), (f)(2), and the second time it appears in (g)(1)(i).

"Contracting Officer" means Contracting Officer and Buyer in paragraphs (d)(1), (d)(3), and (g)(4).

"Contracting Officer" means Contracting Officer or Buyer in paragraphs (c)(1), (c)(2), (c)(3), (c)(4), (c)(5), and (d)(2).

"DoD" means DoD and Buyer in paragraphs (g)(1)(ii) and (g)(3).
- G. CHANGE IN PLACE OF PERFORMANCE - AMMUNITION AND EXPLOSIVES - DFARS 252.223-7003. "Contracting Officer" means Buyer and "Government" means Government or Buyer.

- H. BUY AMERICAN ACT AND BALANCE OF PAYMENTS PROGRAM - DFARS 252.225-7001. Buy American Act - Supplies (FAR 52.225-3 in Buyer Form 70-C-33, Sec. A) is deleted.
- I. QUALIFYING COUNTRY SOURCES AS SUBCONTRACTORS - DFARS 252.225-7002.
- J. DUTY-FREE ENTRY - QUALIFYING COUNTRY END PRODUCTS AND SUPPLIES - DFARS 252.225-7009. The term "contract" is not modified in the terms "Defense Contract Management" and "DoD contracts".

- V. TRANSPORTATION OF SUPPLIES BY SEA - DFARS 252.247-7023. "Contract" is not changed in paragraph (a)(6)(i). In the first sentence of paragraph (c) "through the Buyer" is inserted after "Contracting Officer" and "45 days" is changed to "60 days".
- In paragraph (d), "the Buyer," is inserted after "Contracting Officer".
- In paragraph (f), "Government" and "Contracting Officer" mean Buyer and "for the purposes of the prompt payment clause of this contract" is deleted.
- W. NOTIFICATION OF TRANSPORTATION OF SUPPLIES BY SEA - DFARS 252.247-7024. "Contracting Officer" means Buyer.
- X. RECOVERY OF NONRECURRING COSTS ON COMMERCIAL SALES AND ROYALTY FEES - DFARS 252.270-7000. In paragraph (a)(7), "Contractor" is not changed. In paragraph (f) "Government" means Government and Buyer.
- Y. DISCLOSURE OF INFORMATION - DFARS 252.204-7000.
- Z. INTENT TO FURNISH PRECIOUS METALS AS GOVERNMENT-FURNISHED MATERIAL - DFARS 252.208-7000. "Contractor" is not changed in paragraph (d).
- AA. AUDIT OF CONTRACT MODIFICATIONS--COMMERCIAL ITEMS - DFARS 252.211-7011.
- BB. CLAUSES TO BE INCLUDED IN CONTRACTS WITH SUBCONTRACTORS AND SUPPLIERS--COMMERCIAL ITEMS - DFARS 252.211-7021.
- CC. RESTRICTIONS ON EMPLOYMENT OF PERSONNEL - DFARS 252.222-7000.
- DD. TELECOMMUNICATIONS SECURITY EQUIPMENT, DEVICES, TECHNIQUES, AND SERVICES - DFARS 252.239-7016.
