ADDITIONAL PROVISIONS
(NASA CONTRACTS)

The National Aeronautics and Space Administration Supplement to the Federal Acquisition Regulation (NFS) clause(s), as in effect on the date of this order, which have been marked with an "x" in the appropriate box below, are incorporated herein by reference. In such Clauses, unless otherwise specifically stated, the term "Contractor" means Seller except in the term "Prime Contractor", "Subcontractor" means Seller's subcontractor, "Contract" means this order except in the term "prime contract", and "Contracting officer" means the government contracting officer for the prime contract or authorized representative.

- A. () REPORT ON NASA SUBCONTRACTS - NFS 18-52.204-70. The term "contract" is not changed; "Contractor" means Buyer in paragraph (c), and paragraph (e) is deleted. The prime contract number appears on the faceplate of this order.
- B. () NASA CONTRACTOR FINANCIAL MANAGEMENT REPORTING - NFS 18-52.204-71. "Contracting Officer" and "NASA" means Buyer except in the first sentence; the terms "the Schedule of" and "Schedule" are deleted except in paragraph (e) where "Schedule" means order; and paragraph (d) is deleted.
- C. () NASA CONTRACT OR FINANCIAL MANAGEMENT REPORTING (PERFORMANCE ANALYSIS REPORT) - NFS 18-52.204-72. The term "Contractor" is not changed and "the Schedule of" is deleted.
- D. () NOTICE OF DELAY - NFS 18-52.212-70. "Contracting Officer" means Buyer, "Schedule" means order and "45 days" is changed to "60 days."
- E.() SAFETY AND HEALTH - NFS 18-52.223-70. "Contracting Officer", "Government" and "NASA" mean Buyer; in paragraph (f) "authorized Government representatives of the Contracting Officer" is changed to "authorized Government and Buyer representatives"; and "Contract Schedule" and "Schedule" mean order.
- F. () FREQUENCY AUTHORIZATION - NFS 18-52.223-71.
- G. () POTENTIALLY HAZARDOUS ITEMS - NFS 18-52.223-72. The potentially hazardous items or components referred to in paragraph (a) are:
- H. () INTER PARTY WAIVER OF LIABILITY DURING STS OPERATIONS - NFS 18-52.228-72. Seller agrees to the provisions of this clause, and specifically agrees that it is a party to the waiver of liability set forth in subparagraphs (d)3.b. and (d)3.c. thereof.

- I. () CROSS-WAIVER OF LIABILITY FOR SPACE STATION ACTIVITIES - NFS 18-52.228-76. Seller agrees to the provisions of this clause and specifically agrees to the cross-waiver of liability set forth in paragraphs (c), (d), (e) and (g) thereof.
- J. () PRICING OF ADJUSTMENTS - When costs are a factor in any determination of a contract price adjustment pursuant to the Changes clause or any other provision of this contract, such costs shall be in accordance with Part 31 of the Federal Acquisition Regulation as in effect on the date of this contract. (Ref NFS 18-52.231-70)
- K. () GEOGRAPHIC PARTICIPATION IN THE AEROSPACE PROGRAM - NFS 18-52.244-70.
- L. () ACQUISITION OF CENTRALLY REPORTABLE EQUIPMENT - NFS 18-52.245-70. "Contracting Officer" means Buyer and "30 days" is changed to "45 days."
- M. () INSTALLATION - PROVIDED GOVERNMENT PROPERTY - NFS 18-52.245-71. "Contracting Officer" means Buyer in paragraph (c); "Government" means Government or Buyer in the second sentence of Paragraph (b); and, "Buyer or" is inserted in front of "Installation Supply and Equipment Management Officer" in paragraph (a) and the last sentence of paragraph (b).
- N. () LIABILITY FOR GOVERNMENT PROPERTY FURNISHED FOR REPAIR OR OTHER SERVICES - NFS 18-52.245-72. "Contracting Officer" means Buyer, and "Government" means Government and Buyer the first and second time it appears in paragraph (e).
- O. () FINANCIAL REPORTING OF GOVERNMENT-OWNED/CONTRACTOR-HELD PROPERTY - NFS 18-52.245-73. Delete Paragraphs (b), (d) and (e). Seller shall submit an original and four copies of the annual report to Buyer on or before July 15. The required form shall be submitted directly to:

- Q. () USE OF RURAL AREA SMALL BUSINESSES - NFS 18-52.219-74.

- S. () CROSS-WAIVER OF LIABILITY FOR EXPENDABLE LAUNCH VEHICLE LAUNCHES - NFS 18-52.228-78.
